## Olde Home Day 2008 Rules and Regulations

**APPLICATION:** Applicants for the Town of Clinton's Olde Home Day 2008 must answer all questions on the application, sign and date the Rule and Regulations (this sheet), and return them to the address listed below with the booth fee by August 1, 2008.

**BOOTH FEES:** \$60.00 ALL SALES, INCLUDING RAFFLES, HOME PARTIES, CATALOG SALES  
\$40.00 INFORMATIONAL ONLY

**\$20.00 Early Sign Up Bonus – Deduct \$20.00 on Applications postmarked prior to August 1, 2008**

**HOURS OF OPERATION:** All vendors must be open from 10am to 4pm on Saturday, September 6, 2008

**SET UP:** Load in begins at 6:30am Limited staff will be available to help vendors locate their booth space. NO BOOTH WILL BE ALLOWED TO SET UP PRIOR TO THIS TIME. All set up must be completed and vehicles removed from the streets to designated parking areas by 9:00am.

**BREAKDOWN:** Load out begins at 4:00pm. All booths and vehicles must be cleared from the streets at 6:00pm.

**SALES TAX:** Vendors are responsible for charging and claiming state sales tax.

**RESTRICTIONS:**

- 1). Vendors are not allowed to "ROVE" with their merchandise at any time.
- 2). No alcoholic beverages, pets, loud music or television and no "hawking" will be allowed in the vicinity of your booth.
- 3). There is not staking into the grounds of Central Park.

**SECURITY:** Although limited security is provided, we do not recommend leaving your items in your booth unattended. YOUR BOOTH AND CONTENTS REMAIN YOUR RESPONSIBILITY .Neither the Olde Home Day Committee or the Town of Clinton assumes responsibility for injury to persons, or loss or damage to any property of the vendors, including theft. In signing this agreement, applicant agrees to comply with all festival, state and local regulations, and to save and hold harmless the Town of Clinton, The Olde Home Day Committee, their employees, officers, sponsors and agents from any loss or damage to any persons or property caused by applicant's operation in connection w/Clinton Olde Home Day, and further agrees to defend said Associations and City for any claims for such damage. I have read and understand the above Rules and Regulations and will abide by them throughout my association with Olde Home Day 2008. It is understood that the Olde Home Day Committee reserves the right to close, without refund, any participant not complying with these regulations.
